



RedCat Software licence Transfer Form. Terms and Conditions.

This form can only be used to transfer the ownership of a RedCat software licence in the event of a transfer of ownership of a business and all its assets to a new owner at the same Site Location Address.

The RedCat software licence is not transferable and cannot be sold, transferred or assigned to a new business or a new location without RedCat's prior written consent.

By signing this form, the current registered owner, and the new owner of the RedCat software verify that:

- The business named on the signature page has been sold along with all assets to the new owner listed on the signature page.
- The Business Site Location Address has not changed.
- All copies of RedCat software, including backup copies, cd's and installed versions have been provided to the new owner.
- No copies of RedCat software including any BackOffice management software and any additional modules have been retained.
- Any copies of RedCat software installed on personal PC's, or PC's not related to the sale have been uninstalled and deleted.
- The new owner has read and accepted the Terms and Conditions of the RedCat software Licence agreement.

Both pages of this form must be notarised and accompanied by a Statutory declaration that verifies that the above statements are true and correct.

A non-refundable standard licence transfer fee of \$200 Ex. GST is payable on submission.

RedCat will advise within 2 business days of submission if the transfer has been approved.

Definitions :

The term "RedCat software licence" used in this form means - All installed versions of RedCat Point Of Sale software, BackOffice software and any other software modules associated with this software licence as well as, and including, all backup copies, Cd's, or stored versions of the software and associated documentation.
